**JURISDICTION ORDER OF OFFICERS OF INLAND REVENUE,  
LYALLPUR ZONE, REGIONAL TAX OFFICE, FAISALABAD**

In continuation & partial modification of early jurisdiction orders No.CIR/LYP/RTO/Fsd/106 dated 07.08.2025 and in compliance of Chief Commissioner IR, RTO,Faisalabad special jurisdiction order No. CCIR/RTO/FSD/675 dated: 18.08.2025 and in exercise of powers conferred under Sub-section (1) & (2) of Section 210 of the Income Tax Ordinance, 2001, Section 30 of the Sales Tax Act, 1990 and sub-section (1B) of Section 29 of the Federal Excise Act, 2005, Wealth Tax Act, 1963 (Repealed) and Finance Act, 1989(Act No. V of 1989 as amended vide Finance, Act, 2010), & Islamabad Capital Territory (tax on services) Ordinance, 2001, it is hereby directed that Officer of Inland Revenue, Unit-05 as mentioned at S.No.07 of Column-I of Table-I shall exercise all the powers and perform the functions as specified in column III, as mentioned hereunder, except the powers and functions mentioned in Table-II already specified in the above said jurisdiction orders:-
